This includes but is not limited to Name, Address, Phone Number, Email Address. If authorization is granted you must provide a sample of how and what information is to be collected.
- NOT TO DISTRIBUTE OR DISPLAY ANY SIGNS, MATERIALS OR PRODUCTS, other than goods or products normally offered by the Exhibitor to the public in their place of business.
- Provide the wedding show with a copy of all materials and or product to be distributed at wedding show no later than 21 days prior to the show.
- NOT TO remove any merchandise in your booth and leave your display completely intact until after the last closing of the last show and the show has been officially announced as closed. The Exhibitor also agrees to remove all exhibit merchandise from the building by final move out time, and in failure to do so, will pay for such additional costs as may be incurred.
- That if the Exhibitor receives the Brides Data, the Exhibitor agrees to complete and sign the "Brides Data Release Form".
- In view of the selection, exclusive nature and the unique tie-ins involved, I fully understand and agree that this contract is firm and cannot be cancelled. Further, I agree that I shall waive any rights whatsoever, based on performance or otherwise, with regard to non-payment by me, of sums that shall be due and payable under this agreement.
